



PRIVACY STATEMENT

Jumbo cares about protecting your privacy. This privacy statement describes the practices Jumbo follows to respect privacy of all visitors to the Jumbo website.

Personal data that we process

Registration is not required to use our website. If you are merely a visitor, we do not collect any personal data, except to the limited extent through the use of cookies, which are described below. However, there may be circumstances in which you choose to register. For example, you may choose to register for:

1. Newsletters, position lists or to attend seminars/events

If you decide to subscribe, Jumbo collects basic contact information, such as your name and email address. If you register on our website, your personal data will be stored until you opt out of receiving future publications.

2. Expressing an interest in working for Jumbo

Our site enables you to register your interest in working for us or applying for an advertised vacancy. For more details visit our jobs page. Please refer to the privacy statement on the Jobs page for the applicable retention periods for these initiatives.

You provide us with the data by filling out a contact form, with which you give consent to the processing of your data.

Security

Jumbo has taken appropriate technical and organisational measures to protect your personal data against loss or any form of unlawful processing. All information is treated confidentially and stored on secure servers.

Disclosure

Jumbo may only disclose your personal data outside of Jumbo:

- Where the disclosure is necessary to fulfill your request, and involves a third-party organisation with which Jumbo has a relationship. Jumbo will only disclose personal data to third parties that have agreed in writing to provide an adequate level of privacy protection; or
- When explicitly requested by you, the site visitor; or
- As required by a court order or any other legal or regulatory requirement; or
- Where the disclosure is reasonably related to the sale or other disposition of all or part of our business.

Jumbo may use external service providers to assist with, for example, information technology and other administrative support services to operate our website.





Your rights

Cookies and how we use them

Jumbo uses analytical cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. This means that when you next visit our website the saved information can be returned to our server or to the server of related third parties. On your first visit to our website we inform you about these cookies. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously saved via the settings of your browser.

Google Tag Manager

Jumbo uses Google Analytics to track and receive reports about how visitors use our website and from which IP address. Jumbo tracks visitors anonymously, using anonymised IP addresses. This means that the information collected can't be traced back to an individual.

If legally required, Google may transfer this information to third parties or if third parties process the information on Google's behalf. We have no control over the use of the data by Google/or any third parties. Jumbo has not granted Google permission to use Analytics information obtained through Jumbo for other Google services. The information thus obtained, including the address of your computer (IP address), is transferred to and stored by Google on servers in the United States.
